STATUTORY NOTICE

Notice is hereby given on Friday the 23rd of November, in accordance with section 41 and 43 of the School Standards and Organisation Act (Wales) 2013 and the School Organisation Code that the Isle of Anglesey County Council, having consulted such persons as required, proposes to discontinue Ysgol Gynradd Beaumaris, Beaumaris Ynys Môn LL58 8HL which is currently maintained by the Isle of Anglesey County Council and to refurbish and expand Ysgol Llandegfan and refurbish Ysgol Llangoed. Both of these schools are Welsh medium community school and are maintained by the Isle of Anglesey County Council. Both schools will be for boys and girls aged 3-11.

The Isle of Anglesey County Council undertook a period of consultation before deciding to publish this proposal. A consultation report containing a summary of the issues raised by consultees, the proposer's responses and the views of Estyn is available on the Isle of Anglesey County Council's website (www.anglesey.gov.uk)

It is proposed to implement the proposal on 1 September 2020. The expanded Ysgol Llandegfan and Ysgol Llangoed will be community schools. The Isle of Anglesey County Council (the local authority) will be the admission authority.

The admission number for pupils at expanded Ysgol Llandegfan in the first school year in which the proposals have been implemented is 30. The nursery will provide for 30 children who attend the school on a part-time basis. The pupil capacity of the expanded Ysgol Llandegfan will be 210.

Pupils attending Ysgol Gynradd Beaumaris in the year prior to the new school opening will automatically transfer to Ysgol Llangoed subject to parental preference and in accordance with the Council's School Transport Policy.

Within a period of 28 days after the date of publication of these proposals, that is to say by 22 December 2018 any person may object to the proposals. Objections should be sent to the Programme Manager, Transformation Department, Isle of Anglesey County Council, Council Headquarters, Llangefni LL77 7TW.

EXPLANATORY NOTE

(This Explanatory Note does not form part of the Notice but is offered by way of clarification)

This is a statutory notice saying that Ysgol Gynradd Beaumaris will close and the pupils will transfer to Ysgol Llangoed from 1 September 2020 at the earliest. Ysgol Llandegfan and Ysgol Llangoed will continue to be Welsh medium community primary schools.

Current school transport policy provides free transport for primary school pupils who meet each of the following criteria:

- a) are of compulsory school age;
- b) attend the nearest or the school designated by the Local Authority; and
- c) where the distance from the home to the school is more than 2 miles.
